CALL THE MEETING TO ORDER

Mrs. Visconi called the meeting to order at 7:02 PM in the Board of Health meeting room located on the second floor of the Municipal Building at 116 Paris Avenue, Northvale, New Jersey 07647.

SECRETARY'S REPORT

Mrs. Weston advised the members that there have been 185 dog licenses renewed. Letters have been sent out to the ones not renewed. Last year we issued 231 dog licenses. There were 22 cat licenses renewed. All food licensed have been removed. Thank you to the County Board of Health for getting the final few establishments renewed. The rabies clinic will be October 7th. David will handle the flu shots same as last year. Next meeting is June 19th at 7 PM.

NEW BUSINESS – Proposed Chicken Ordinance

Mrs. Visconi asked the members to discuss the proposed ordinance they received from the Borough Attorney which would allow chickens. She went over the different parts of the ordinance. Councilman Sokoloski explained the zoning officer will be the one to enforce this. Mrs. Hunkin feels this will be very difficult to enforce. Mr. Yoon stated that having this ordinance is better than what we currently have. If we can enforce this, it will have a positive



effect. Councilman Sokoloski explained the process of changing the ordinance which would be to introduce the ordinance then at the next meeting adopt it. Dr. Levine asked how many complaints have there been in the last two years. Mrs. Uglione was concerned about the distance from your home. Joe Gauiter from the County Board of Health advised the members that the Board of Health handles public health nuisance complaints such as odor or rodent complaints. Mrs. Hunkin is against this. Mr. Yoon thinks if we can guarantee enforcement it would be good.

Councilman Sokoloski told the members he is for allowing chickens and so is the Mayor and rest of the council.
