# **RESOLUTION #2023-59**

TITLE: RESOLUTION AUTHORIZING A CONTRACT WITH ARCARI + IOVINO FOR ARCHITECTURAL SERVICES FOR A CDBG FUNDED BOROUGH HALL – ADA COMPLIANT MAIN ENTRANCE

**WHEREAS,** the Borough is in need of an ADA code compliant main entrance for the Borough Hall; and

**WHEREAS,** there is funding for this project through a Community Development Block Grant; and

**WHEREAS,** the firm of Arcari +Iovino is familiar with the administration process for this grant and can provide the necessary architectural services; and

**WHEREAS,** Arcari + Iovino has submitted a proposal dated January 24, 2023 (attached) for their services for this project in the sum of \$8,000, which service and amount does not require competitive bidding; and

WHEREAS, the Borough finds the proposal to be reasonable and suited for the project.

**NOW, THEREFORE BE IT RESOLVED**, by the Governing Body of the Borough of Northvale that the Governing Body does accept the proposal by Arcari + Iovino and does hereby authorize the execution of an agreement by the Mayor and Borough Clerk with Arcari + Iovino for the services set forth herein.

Mayor McGuire feels that the professional services overall will be a cost savings. The two biggest contracts are the Attorney and Borough Engineer. We are doing something different this year with our Attorney working off of a flat fee instead of retainer. The prior Attorney showed a fee of \$75,000 but the bills at the end of the year would be \$95,000. The current Attorney's flat fee is \$90,000 with no limitation on how we can use them and how often we can use them. Employees can call them without a fear of running up a bill for the Borough. As for the Borough Engineer, in the past, we would pay lump sums for projects. Our current Engineer is a time and material cost. He has spoken to other communities that use this Engineer and they are happy with the costs and savings from Engineers they used in the past. The prior Tax Attorney had a cap of \$50,000, now the cap is \$25,000. Grants are a bit higher but we are looking to receive more grants. These are all one year contracts and we will see how they are going to work out. Resolution #2023-59 was a Community Development grant that was awarded the end of 2021. Mayor McGuire was not sure why nothing moved on this in 2022. The deadline is April 7<sup>th</sup> but we are trying for an extension. If we can get the project out to bid and started the County will be happy.

**ON THE QUESTION** – Councilman Hogan questioned Resolution #2023-47 which is the one year contract for the Borough Attorney. He further stated that this is nothing personal purely a financial position that he cannot support. He thinks we should try to do whatever we can to save as much money for the taxpayers. He continues that increasing the retainer an additional \$15,000, knowing we will see the Attorney once a month at a bare minimum he doesn't agree with. There is no need to be emailing or calling the Attorney at the rate you persevere. Also Resolution #2023-56, he hopesthat the new grantswriter can obtain different grants.

Councilman Sokoloski said that Resolution #2023-59 was surprised that the Borough sat on the CD grant for the Borough Hall ADA doors. He is glad to hear the County will give an extension. He feels the proposal from Arcari + Iovino is a reasonable one. Scott spoke to the County on Monday and was told that the funds do not go away. They are in an account and if we do not hit the deadline, they will not pull funds from us. We need to be transparent with them and they will work with us.

### **ORDINANCE #1060-2023**

AN ORDINANCE OF THE BOROUGH OF NORTHVALE AMENDING CHAPTER 46 OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF NORTHVALE ENTITLED "PUBLIC WORKS DEPARTMENT"

**WHEREAS**, the Governing Body of the Borough of Northvale deems it in the best interest of the Borough to amend Chapter 46 of the Borough Code regarding the "Members" of the Public Works Department

**NOW, THEREFORE BE IT ORDAINED,** by the Governing Body of the Borough of Northvale, County of Bergen, State of New Jersey, as follows:

**SECTION 1**. § 46-2 Members of the Borough Code shall be amended and replaced with the following:

§ 46-2 **Members.** 

The Department of Public Works shall consist of one Superintendent, and in the discretion of the Governing Body, there may be an Assistant Superintendent, foremen, and such other Department of Public Works employees as determined by the Governing Body. The Superintendent shall be designated by the Mayor and Council in accordance with the provisions of N.J.S.A. 40:87-30 and any subsequent amendments.

### **SECTION II**

All Ordinances or parts thereof inconsistent with the provisions of this Ordinance be and the same are hereby repealed to the extent of such inconsistencies.

### **SECTION III**

Should any section, paragraph, clause of any other portion of this Ordinance be adjudged by a Court of competent jurisdiction to be invalid, such judgment shall not affect or impair the remainder of this Ordinance.

### **SECTION IV**

This Ordinance shall take effect upon its passage and publication according to law.

**ON THE QUESTION** – Councilman Hogan stated that he is not supporting this Ordinance. DPW structure is set up with our budget in line. Mayor McGuire answered that was a fair assessment but it is up to the Council not to abuse these ordinances and he likes the flexibility to serve the public better.

#### **ORDINANCE #1061-2023**

AN ORDINANCE OF THE BOROUGH OF NORTHVALE CREATING A NEW CHAPTER 47 OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF NORTHVALE TO BE ENTITLED "REGISTRATION OF BUSINESS AND RENTAL UNIT INSURANCE"

**WHEREAS**, P.L. 2022, c. 92 recently enacted by the New Jersey Legislature and signed by the Governor into law requires the owners of certain Businesses and rental units to maintain certain minimum liability insurance coverages; and

**WHEREAS**, the aforesaid statute requires such owners to annually file certificates of insurance evidencing the required coverages with the municipality in which the Business is located:

**NOW, THEREFORE BE IT ORDAINED,** by the Governing Body of the Borough of Northvale, County of Bergen, State of New Jersey, as follows:

### **SECTION 1**

There is hereby created Chapter 47 of the Revised General Ordinances of the Borough of Northvale entitled "REGISTRATION OF BUSINESS AND RENTAL UNIT INSURANCE."

### SECTION 1 BUSINESS INSURANCE REGISTRATION

### § 47-1 Purpose.

It is the purpose of this Chapter to comply with the requirements imposed upon the Borough by P.L. 2022, c. 92, which provides for the annual registration of Certificates of Insurance by Business owners and the owners of rental units located in the Borough.

### §47-2 Definitions.

The following words and phrases, when used in this Chapter, shall have the meanings ascribed to them in this Section, except where the context clearly indicates a different meaning:

### **BUSINESS**

Shall mean any person offering and/or engaged in buying, selling, storing and/or transferring merchandise, goods, real property, personal property, moneys, services and/or other items who do so for a fee, price, retainer, commission, percentage and/or other means of compensation for the purpose, stated or otherwise, of realizing a profit or other gain.

# CERTIFICATE OF REGISTRATION

Shall mean the certificate issued by the Municipal Clerk indicating compliance with the registration requirements of P.L. 2022, c. 92.

# CERTIFICATE OF INSURANCE

Shall mean the certificate of insurance form submitted by each Business.

## **MUNICIPALITY**

Shall mean the Borough of Northvale

### §47-3 Insurance Requirements.

- a. As required by the aforesaid statute and except as provided in subsection b. of this section, the owner of a Business or the owner of a rental unit or units shall maintain liability insurance for negligent acts and omissions in an amount of not less than \$500,000 for combined property damage and bodily injury to or death of one or more persons in any one accident or occurrence. The provision of this section shall take effect on the 90<sup>th</sup> day next following enactment for all new policies issued on or after the 90<sup>th</sup> day following enactment and shall take effect on the 180<sup>th</sup> day next following enactment for all policies in force on the date of enactment that are renewed on or after the 180<sup>th</sup> day next following enactment of P.L. 2022, c. 92.
- b. The owner of a multifamily home which contains four or fewer units, one of which is owner-occupied, shall maintain liability insurance for negligent acts and omissions in an amount of not less than \$300,000 for combined property damage and bodily injury to or death of one or more persons in any one accident or occurrence. The provisions for this section shall take effect on the 180<sup>th</sup> day next following enactment and shall apply to policies issued or renewed on or after the 180<sup>th</sup> day following enactment of P.L. 2022, c. 92.

## §47-4 Registration Requirements; Certificate of Registration.

The owner of a Business, the owner of a rental unit or units, and the owner of a multi-family home of four or fewer units, one of which is owner occupied, shall register annually by filing a copy of a Certificate of Insurance with the Municipal Clerk, demonstrating compliance with P.L. 2022, c. 92.

- a. The copy of the Certificate of Insurance shall be filed with the Municipal Clerk no later than thirty (30) days after the issuance or renewal of the policy or policies of insurance required to be maintained by said owner.
- b. The Municipal Clerk shall issue a Certificate of Registration to each owner who files a Certificate of Insurance demonstrating compliance with P.L. 2022, c. 92. and the required registration fee. A new Certificate of Registration shall be required annually for each calendar year.

# §47-5 Registering Two or More Businesses or Locations.

- a. In the event that two (2) or more Businesses occupy the same location, the owner of each Business shall be required to submit a Certificate of Insurance for each such Business.
- b. In the event that the same owner conducts business at two (2) or more locations within the Municipality, a separate Certificate of Insurance shall be required for each location

## §47-6 Compliance with Applicable Laws and Ordinances.

Issuance of a Certificate of Registration certificate by the Municipal Clerk does not evidence compliance with other applicable rules, regulations, ordinances and statutes of the Municipality, County and State of New Jersey, or other regulatory agencies having jurisdiction over the activities of the certificate holder.

# §47-7 Registration Fee.

The registration fee to be paid prior to issuance of each Certificate of Registration by the Municipal Clerk shall be the sum of one hundred dollars (\$100.00).

### § 47-8 Failure to Register, Penalties.

Pursuant to N.J.S.A. 40A:10A-2.b., the governing body of the Borough may collect, through a summary proceeding pursuant to the "Penalty Enforcement Law of 1999," P.L.1999, c.274 (C.2A:58-10 et seq.), a fine of not less than \$500 but no more than \$5,000 against an owner who has failed to comply with the provisions of P.L. 2022, c. 92.:

### **SECTION II**

All Ordinances or parts thereof inconsistent with the provisions of this Ordinance be and the same are hereby repealed to the extent of such inconsistencies.

#### **SECTION III**

Should any section, paragraph, clause of any other portion of this Ordinance be adjudged by a Court of competent jurisdiction to be invalid, such judgment shall not affect or impair the remainder of this Ordinance.

#### **SECTION IV**

This Ordinance shall take effect upon its passage and publication according to law.

**ON THE QUESTION** – Councilman Sokoloski asked how the Borough will enforce this. Mr. Ferraro answered that the State does not think of these things. Notices will be sent to the businesses.

Mayor McGuire opened the meeting to the public for questions or comments on Ordinance #1061-2023.

**Edward Durfee, 215 Livingston Street** – has a data processing business in town. He doesn't serve anyone coming into his house. Does he need to have this insurance? Mr. Ferraro answered that this language was not created by us as it was from the State statute. The insurance is for any business which includes services. Every business has to submit a certificate of insurance showing the business is covered.

The class is for free except for the cost of books and course materials. There are 16 signed up so far. The Northvale Ambulance Corps, Norwood EMS, and the Mayor and Councils are exploring solutions to the staff issues and response issues. Volunteers are needed. In December, the Police had their first Coffee with a Cop event at Paris Baguette which was a huge success. Future events are being planned. For the month of January, there were 558 total events.

Councilman Menafra – reported the Fire Department had 29 calls for the month of January. Chief Smithson has been working with our grantwriter to get federal funds for firefighting equipment. They are targeting replacement of rescue truck and pick up truck. Fire Prevention performed 25 inspections and 12 reinspections for January. Northvale Board of Education had their Reorganization meeting on January 5<sup>th</sup>. John Briguglio was sworn in for a 3 year term. Mrs. Venditti was nominated and appointed as BOE President and Mrs. Cowley was nominated and appointed as BOE Vice President. They had a school holiday fund raiser for families in need and donations were made to 75 Bergen County families in the Norwood food pantry. Next regular meeting was held on January 26<sup>th</sup>. The Ryan's story suicide prevention presentation was given by Mr. Halligan, the father of a suicide victim, to Grades 5-8 students on January 19th. Middle school exterior doors were replaced with smaller glass. On January 26<sup>th</sup> Korean family

association sponsored an international night. Next meeting is February 16<sup>th</sup> at 6:30 PM. Northern Valley Board of Education had their Reorganization meeting on January 5<sup>th</sup>. Joseph Saunier was sworn in as Northvale representative. Next regular meeting was held on Jan 23<sup>rd</sup> with the marching band receiving an award as did other student leadership and sports teams. The main issue of discussion was the entrance to the lower field which has been blocked off at the request of the Old Tappan council. Harrington Park residents used it as a drop off in the morning. Next meeting will be February 13<sup>th</sup>.

Councilman Argiro – reported Recreation basketball and indoor soccer are in full swing. There will be no playoffs at the elementary level for basketball. There has been inadequate gym time available. Mayor McGuire is looking into other options. Registration is open for baseball, softball, and adult softball. Opening day has not been decided on as yet. Library renovations are underway. Councilman Sokoloski is monitoring the renovations. Thank you to DPW for helping the Library. A new Director has been hired. Lauren Magielnicki from Rutherford area. She will start on March 6<sup>th</sup>.

Councilman Mattessich – reported he met with Briant and Billy at the DPW several times. They have been working on having a tree cut down on Livingston Street which is surrounded by large, high voltage wires. They have also been cleaning catch basins, painted the Building Department office, repaired manhole covers on Tappan Road, pothole repairs, and appliance pick ups. Leigh Meola from the Beautification Committee met with Briant and Billy to go over things to do at the parks to beautify the parks. Leigh would also like to beautify Paris Avenue or Livingston Street when you come into town. He met the Senior Director, Michelle Adoni and discussed the Senior Center activities. The Valentine's day party is set for next week. Maureen Felici and Jane Ratto have been very helpful to her. The transition has been pretty smooth. He also met with Augie from the Golden Age Club.

Councilman Hogan – reported the Building Department issued 8 permits and collected \$4,433 in fees for the month of January. The revenue is low, as per January, and will pick up when it gets warmer. Planning Board had their Reorganization meeting on January 4th. Charlie Amorosso was appointed the Chairman and Chief Eddie Giannotti appointed the Vice Chairman. Congratulations to Nicole Cowley who has been the Planning Board Secretary for a few years and congratulations to Julia Martino on becoming the new Planning Board Secretary. Gregg Paster was reappointed as Planning Board Attorney and Neglia Group has been appointed as Planning Board Engineer. Welcome to the new members, Michael Puppelo, Andy Gullestad, Chief Ostrow, and Mayor McGuire. The Mayor reappointed Wayne Degen and Ryan Moran. There was one application, 195 High Street, for an apartment that is grandfathered in. Mr. Guyt presented a letter from Mr. Perretti who lived there before 1965. The board directed the Attorney to draw up a Resolution which was passed at the January 18<sup>th</sup> meeting. At that meeting there was one application for 401 Paulding and 497 Tappan Road. The applicant was Kens Tree. He is looking to buy a piece of Mrs. Rossi's property. It will be kept as own unique piece and not combine with his property. It will be kept as buffer zone. Residents were against it at first but then heard stipulations the Planning Board put in. The application was approved. February 1 meeting was cancelled as was February 15<sup>th</sup> for lack of applications ready to be heard. Next meeting is March 1st at 7:30 PM. Insurance and risk manager Looking forward to working with Mayor Barsa who brings a wealth of knowledge in regards to municipal government. Spoke with Peter Perretti to get started on the Flood Committee get active and involved. Hopefully will get some volunteers. Congratulations to Councilman Sokoloski looking forward to working with him.

# **Councilman Sokoloski** – had no report at this time.

**Mayor McGuire** – garbage and recycling bid closes on March 30<sup>th</sup>. The current contract was extended to April 30<sup>th</sup>. We have a four month extension from our previous contract. We are paying the new rates as of January 1<sup>st</sup> which are 41% higher than last year. The RFQ for IT services was due on Friday and would like to move on this swiftly. Since November into January, he has been doing informal surveys of borough employees and operations. We need updates across the board. We have a corporate network that runs off a 2008 Server which is unacceptable andneeds to be fixed. Residents cannot pay taxes on line and cannot renew dog licenses and garage sale permits. We need to bring the Borough into 21<sup>st</sup> century. Our own employees cannot see paychecks online in a portal. They have to wait for a paper check. Boro hall employees do not have photo IDs. They use keys to go into doors, what if key is lost or

copied. Employees use paper time sheets. So many things need to be prioritized to bring into modern world, Physical infrastructure needs attention such as this building, police need attention as does DPW garage. He complimented the DPW on painting the building department which saved the town \$3,000. We were awarded a grant for a dog park at Veterans Park in December for \$26,000 which is a matching grant. We have until the end of 2024 to complete. Congratulations to our finance team for rolling over from 2022 to 2023 which was done on February 1st and is 4-6 weeks ahead of previous years. We can now pay our bills. Joe Luppino, Nicole, and Suzanne did a great job getting this done. There is 24% increase in health benefits, 10% to pension, increase of \$340,000 garbage and recycling. We have \$500,000 in expenses that we didn't have last year. Joe Luppino will begin budget meetings next week. Our new QPA, Antoinette Kelly, will implement new purchasing guidelines. He is starting health and wellness campaign with funding from the county and state. It will be physical fitness, nutrition, mindfulness, mental health, etc. Kickoff will be March 18th at Hogan Park with a Mayor and Council walk in conjunction with Shoprite. At the February open mic night, which is the 4<sup>th</sup> Tuesday of the month, we will feature a proposed plan for the growing and manufacturing of cannabis in the industrial area. We are facing some budgetary challenges and infrastructure challenges going forward. This is perfectly legal and can generate revenue. We are looking for the public's input.

## **BOROUGH ATTORNEY REPORT**

Mr. Ferraro – closing on property on Scharer Avenue will be in the next couple of weeks. Police contract is being reviewed by Joe Luppino. We need to decide if we are moving forward with the Dog Park with matching funds and sign the contract. He is working on a current issue of entering into a contract with Cho Dae Church with Police providing overtime service and getting paid.

### **BOROUGH ENGINEER REPORT**

Mr. Lovitch – Paris Avenue/Livingston Street inspector has items to talk to the contractor about. Contractor will replace the 2 light posts. Borough Inspector did electrical inspection on January 21<sup>st</sup>. He will submit to O&R and it will take 2 weeks to start service. Working on 2023 Riverside Coop list of roads. New projects are Veterans Drive DOT funded grant, dog park, Senior Center door. The Architect will expedite plans and receive quotes in two weeks for the Borough Hall doors. Perry Street drainage is near completion. Reached out to Old Tappan Engineer. Currently, the pipe is 18" and they want to increase to 42". Sending letter tomorrow on impact to Northvale if Old Tappan cannot convert to our system.

### OPEN MEETING TO THE PUBLIC

Mayor McGuire opened the meeting to the public. There being no questions or comments from the public, Mayor McGuire closed the meeting.
